

ORDER DENYING MOTION FOR RECONSIDERATION

In response to a decision entered on December 1, 2015, Respondent submitted its Motion for Reconsideration on December 11, 2015. Petitioners responded to the Motion on December 21, 2015. After due consideration and for the reasons set forth below, the Respondent's Motion is **DENIED**.

Reconsiderations are not a matter of routine practice. For a party to obtain reconsideration, the movant "must set forth facts or law of a strongly convincing nature to induce the court to reverse its prior decision." Coppage v. United States Postal Serv., 129 F. Supp. 2d 1378, 1379 (M.D. Ga. 2001). Reconsideration is "an extraordinary remedy to be employed sparingly." Id. As such, motions for reconsideration should be granted only in "certain limited situations, namely the discovery of new evidence, an intervening development or change in the controlling law, or the need to correct a clear error or prevent a manifest injustice." Preserve Endangered Areas of Cobb's History, Inc. [P.E.A.C.H.] v. United States Army Corps of Eng'rs, 916 F. Supp. 1557, 1560 (N.D. Ga. 1995). In its Motion, Respondent merely repackaged and

repeated the same arguments it made at hearing and in its subsequent briefs. Moreover, the Motion contained no new facts and did not aver a change in the controlling law.

Accordingly, this Court having reviewed Respondent's Motion For Reconsideration and Brief in support thereof, and having considered same, the Motion For Reconsideration filed by Respondent is **DENIED**.
